BY-LAW NUMBER 00-90

A BY-LAW TO AUTHORIZE THE TRANSFER OF APPROXIMATELY 1.53 ACRES ON FISHER DRIVE, BEING PART OF LOT 8, CONCESSION 10, FORMERLY IN THE TOWNSHIP OF NORTH MONAGHAN, NOW IN THE CITY OF PETERBOROUGH, COUNTY OF PETERBOROUGH, TO KAWARTHA PINE RIDGE DISTRICT SCHOOL BOARD AND TO AUTHORIZE THE ACQUISITION OF APPROXIMATELY 1.36 ACRES ON O'CARROLL AVENUE, IN THE CITY OF PETERBOROUGH, IN THE COUNTY OF PETERBOROUGH AND BEING PART OF BLOCK D, PLAN 101 FOR THE CITY OF PETERBOROUGH, COUNTY OF PETERBOROUGH, FROM THE KAWARTHA PINE RIDGE DISTRICT SCHOOL BOARD

WHEREAS The Corporation of the City of Peterborough deems it expedient to transfer the lands hereinafter described pursuant to the provisions of the *Municipal Act*, such lands being no longer required for the purposes of The Corporation of the City of Peterborough;

AND WHEREAS The Corporation of the City of Peterborough deems it expedient to acquire the lands hereinafter described pursuant to the provisions of the *Municipal Act*, such lands being required for the purposes of The Corporation of the City of Peterborough;

NOW THEREFORE THE CORPORATION OF THE CITY OF PETERBOROUGH BY THE COUNCIL THEREOF HEREBY ENACTS AS FOLLOWS:-

1. It is hereby authorized and decreed that The Corporation of the City of Peterborough transfer the lands described as approximately 1.53 Acres on Fisher Drive, being part of Lot 8, Concession 10, formerly in the Township of North Monaghan, now in the City of Peterborough, County of Peterborough, to Kawartha Pine Ridge District School Board, such lands being no longer required for the purposes of The Corporation of the City of Peterborough.
2. It is hereby authorized and decreed that The Corporation of the City of Peterborough acquire the lands described as approximately 1.36 Acres on O'Carroll Avenue, being part of Block D, Plan 101, for the City of Peterborough, County of Peterborough from Kawartha Pine Ridge District School Board, such lands being required for the purposes of The Corporation of the City of Peterborough.
3. That the Mayor and Clerk are hereby authorized to perform all acts and to take such steps and execute such documents under the seal of the Corporation as may be necessary to effect such transfer and acquisition.
