**BY-LAW NUMBER 02-035**

**BEING A BY-LAW TO REMOVE A HOLDING SYMBOL FROM  
THE ZONING BY-LAW FOR LANDS LOCATED NORTH OF  
CUMBERLAND AVENUE AND WEST OF CARNEGIE AVENUE  
(HERITAGE PARK)**

**THE CORPORATION OF THE CITY OF PETERBOROUGH BY THE  
COUNCIL THEREOF ENACTS AS FOLLOWS:**

**WHEREAS** pursuant to Section 36 of the Planning Act, R.S.O. 1990, c.P.13, a Holding Symbol was applied to the above lands by By-law 00-058.

**AND WHEREAS**, in the opinion of Council, the condition for the removal of the Holding Symbol has been satisfied;

**NOW THEREFORE THE CORPORATION OF THE CITY OF  
PETERBOROUGH BY THE COUNCIL THEREOF ENACTS AS FOLLOWS:**

1. Paragraph 2 of the By-law No. 00-058 is hereby deleted.
2. Map forming part of Schedule 'A' to By-law 1997-123 is amended by changing the rea shown on the sketch attached hereto as Schedule 'A' from **R.1-162 –“H”;** **R.1,2m, 4f-162 –“H”;** **R.1, 1r,2r – 162 – “H”** and **R.1, 4f – 162 – “H”** to **R.1 – 162;** **R.1,2m, 4f-162;** **R.1, 1r, 2r-162** and **R.1, 4f – 162.**
3. This by-law shall come into effect on the date of the passing thereof, subject to the provisions of Section 36 of the Planning Act.

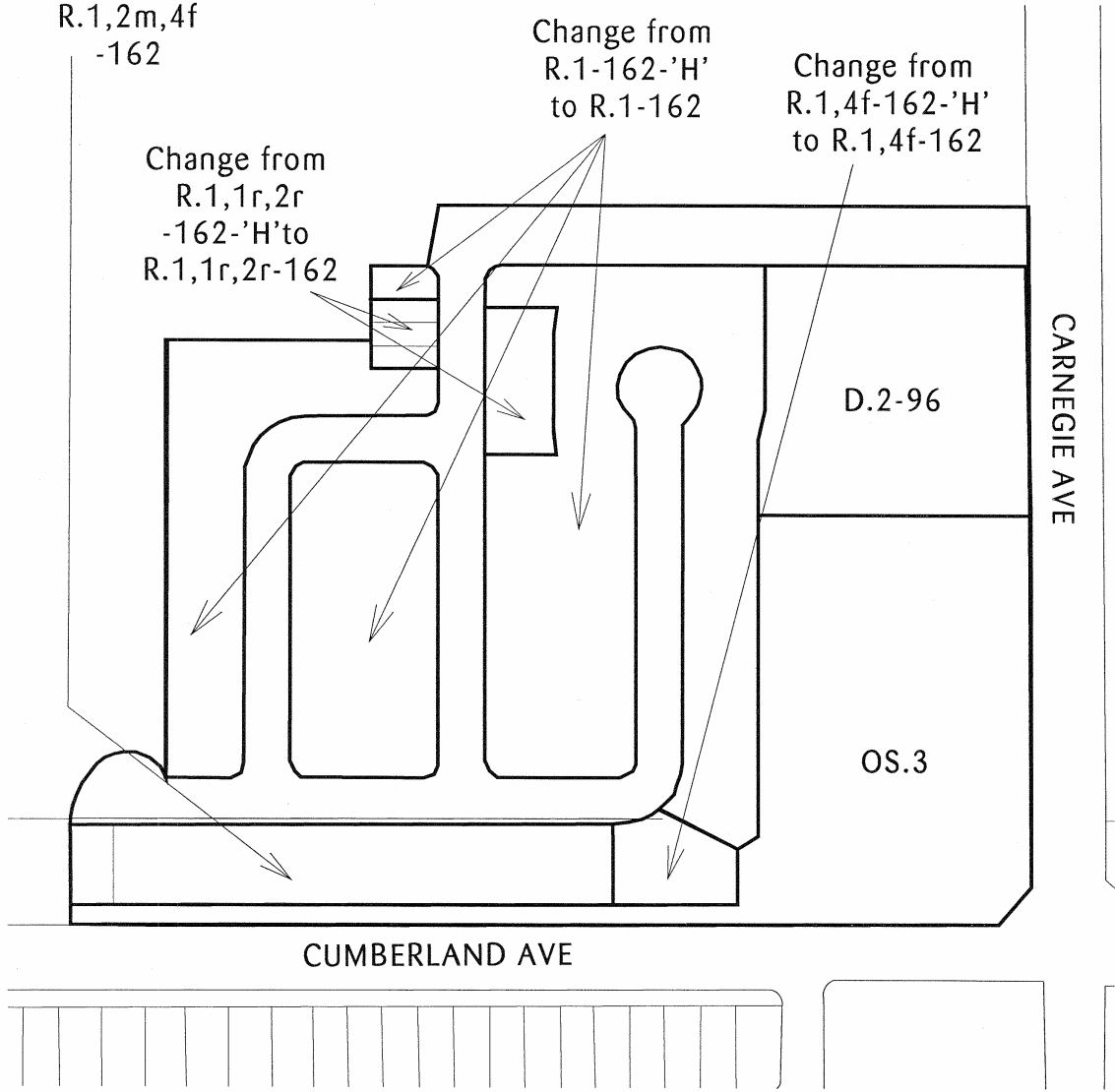
