**BEING A BY-LAW TO AMEND CHAPTER 93 OF THE CITY OF
PETERBOROUGH MUNICIPAL CODE**

THE CORPORATION OF THE CITY OF PETERBOROUGH BY THE COUNCIL
THEREOF HEREBY ENACTS AS FOLLOWS:

1. That Section 93.1.1, 93.2.1, 93.2.2 and 93.2.3 be amended by deleting the name “Steven F. Brickell” and substituting the name “Nancy Wright-Laking” therefore
2. By-law Number 1988-157 and 94-234 are hereby repealed.
3. This Chapter shall come into force and take effect on July 2, 2002

BY-LAW NUMBER 12-048

BEING A BY-LAW TO AMEND CHAPTER 93 OF THE CITY OF PETERBOROUGH MUNICIPAL CODE RESPECTING THE APPOINTMENT OF AN ACTING CLERK

THE CORPORATION OF THE CITY OF PETERBOROUGH, BY THE COUNCIL THEREOF HEREBY ENACTS AS FOLLOWS:

1. That Articles 1 and 2 of Chapter 93 of the City of Peterborough Municipal Code are hereby repealed and the following substituted therefore:

**“Article 1
Appointment**

93.1.1 John Kennedy

John Kennedy is hereby appointed Acting Clerk of the Council of The Corporation of the City of Peterborough.

**Article 2
Duties**

93.2.1 Assigned - by *Municipal Act* - other Acts

John Kennedy shall perform all the duties assigned to him in his capacity as Acting Clerk as set out in the *Municipal Act* and in all such other Acts of the Statutes of Ontario.

93.2.2 As assigned - by Administrator

John Kennedy shall perform all such other duties as may be assigned to him by the Administrator.

93.2.3 Declaration of Office - taken - first

John Kennedy shall take the Declaration of Office before entering upon his duties.”

2. That this By-law come into force and effect on April 14, 2012.
3. Bylaw 02-073 is repealed effective April 14, 2012.
