**BEING A BY-LAW TO AUTHORIZE AN AGREEMENT WITH
TEACHERS FOR KIDS FOR FUNDING OF EXTRACURRICULAR
ACTIVITIES FOR STUDENTS FROM LOW-INCOME FAMILIES**

THE CORPORATION OF THE CITY OF PETERBOROUGH BY THE COUNCIL
THEREOF HEREBY ENACTS AS FOLLOWS:

1. That the Mayor and the Clerk be and they are hereby authorized to execute an Agreement between The Corporation of the City of Peterborough and Teachers For Kids in the form attached hereto as Schedule "A", and to affix the seal of the Corporation thereto.

hereinafter called the "City"

OF THE FIRST PART

- and -

TEACHERS FOR KIDS

hereinafter called the "Manager"

OF THE SECOND PART

WHEREAS the Manager is a registered charity, the mandate of which is to assist elementary and secondary school students enrolled with the Kawartha and Pine Ridge School Board with the financial means to participate in various extracurricular activities that would otherwise be unable to them, because of financial barriers;

AND WHEREAS, under the National Child Benefit Reinvestment Program (Ontario), hereinafter called "NCB", the City as the Consolidated Service Manager, wishes to enter into this agreement with the Manager to provide funding in accordance with the mandate of the NCB;

NOW THEREFORE the parties hereto mutually covenant and agree as follows:

1. The City shall provide to the Manager funding in the amount of Twenty-five Thousand Dollars (\$25,000.00), to be used by the Manager in the "Teachers for Kids" program, as described in this agreement.
2. The Manger shall provide to the City a full report of the funds disbursed and the number of clients served, by April 30, 2003.
3. This agreement shall be in force for the 2002-2003 school year. Notwithstanding this, the City may terminate this agreement forthwith in the event that the Manager makes an assignment in bankruptcy, if a Receiver is appointed by the creditors of the Manager, or if the Manager utilizes the funding for any purpose other than authorized by this agreement. In the event that the agreement is terminated by the City, the Manager shall provide a full accounting to the City of the funds disbursed to the date of termination, and shall return any undisbursed funds to the City.
4. The Manager shall indemnify and save the City harmless from any and all actions, claims, demands, expenses or costs made or brought against the City by any person or persons in respect of damages caused by any act or omission of the Manager, or any of its employees or agents, in the administration of the Teachers For Kids Program pursuant to this agreement.

5. The Manager agrees to acknowledge sponsorship by the Social Services Department of the City in promotional materials, promotional presentations and client service encounters.
6. This agreement shall enure to the benefit of and be binding upon the parties hereto and their respective successors and assigns.
