

THE CORPORATION OF THE CITY OF PETERBOROUGH

BY-LAW NUMBER 03-037

BEING A BY-LAW TO AUTHORIZE THE ACQUISITION OF CERTAIN LANDS IN THE CITY OF PETERBOROUGH AND IN THE TOWNSHIP OF CAVAN-MILLBROOK-NORTH MONAGHAN FROM PETERBOROUGH INDUSTRIAL DEVELOPMENT CORPORATION.

WHEREAS The Corporation of the City of Peterborough deems it expedient to acquire the lands hereinafter described pursuant to the provisions of the *Municipal Act*, such lands being required for the purposes of The Corporation of the City of Peterborough;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF PETERBOROUGH ENACTS AND BE IT ENACTED AS FOLLOWS:

1. It is hereby authorized and decreed that The Corporation of the City of Peterborough acquire the lands described as on Schedule "A" attached hereto.
2. That the Mayor and Clerk are hereby authorized to perform all acts and to take such steps and execute such documents under the seal of the Corporation as may be necessary to effect such purchase.
3. By-law 03-022 is hereby repealed.
