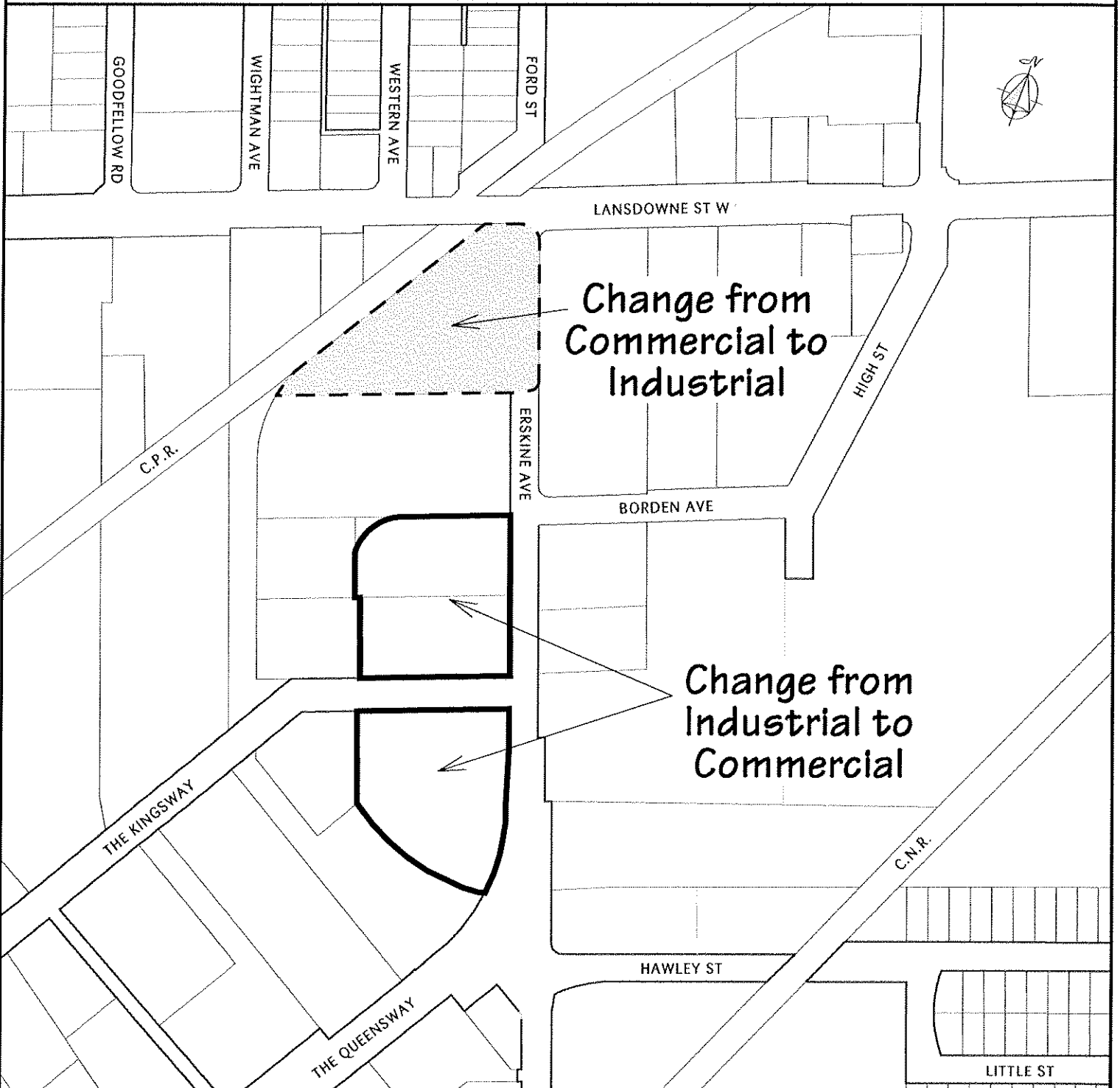

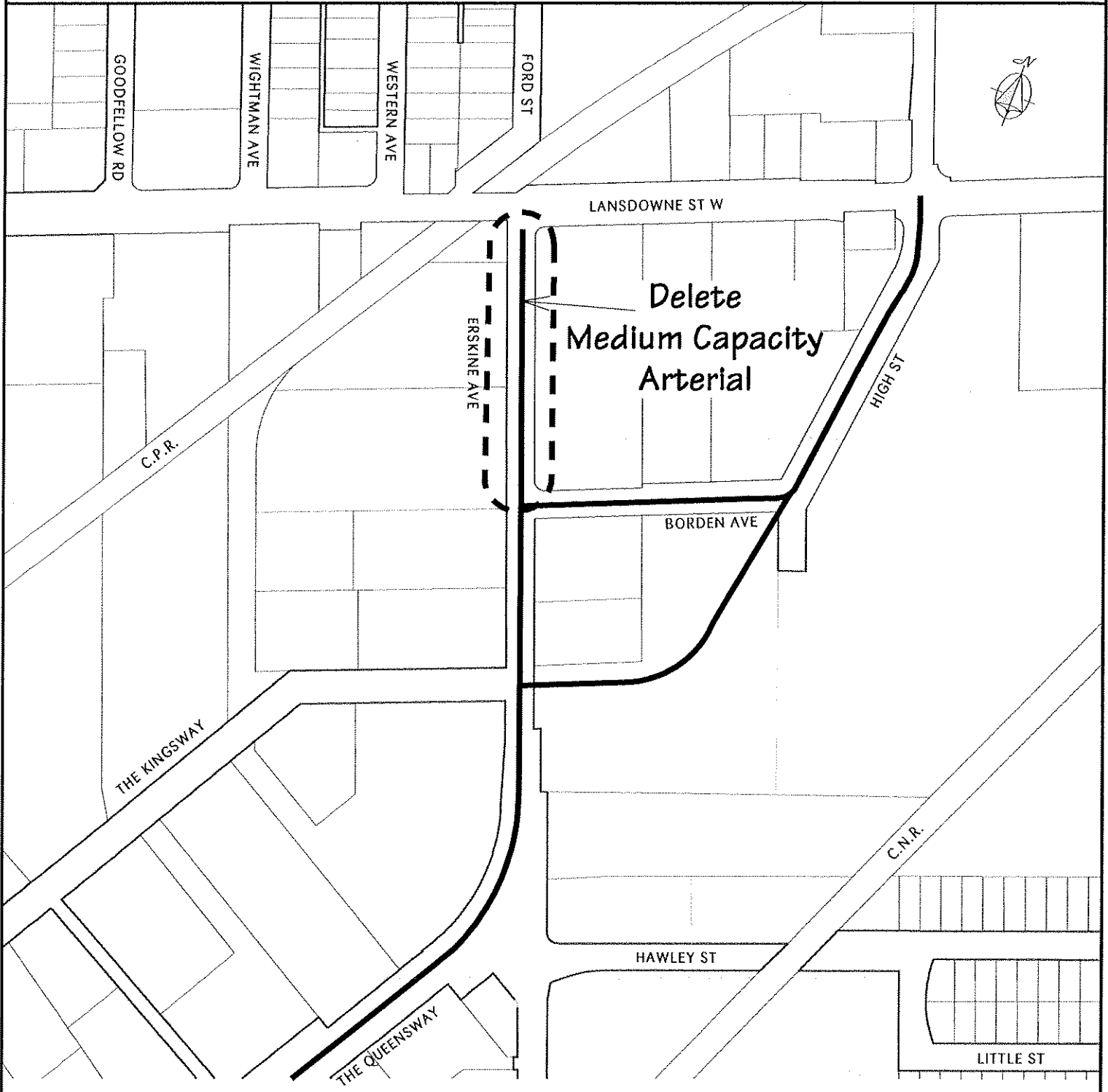
Official Plan Amendment to Schedule - 'A'

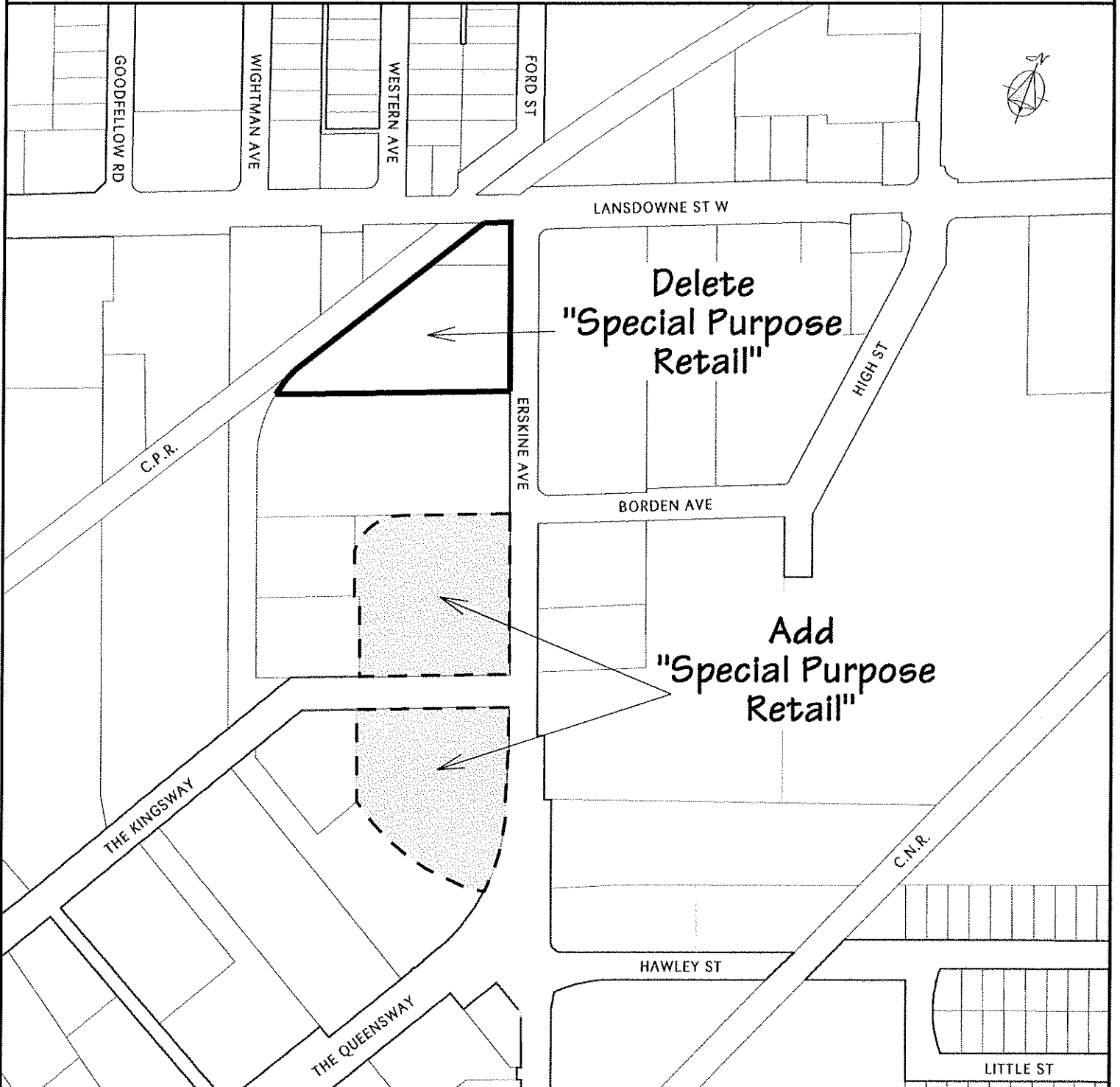

Official Plan Amendment to Schedule - 'I'

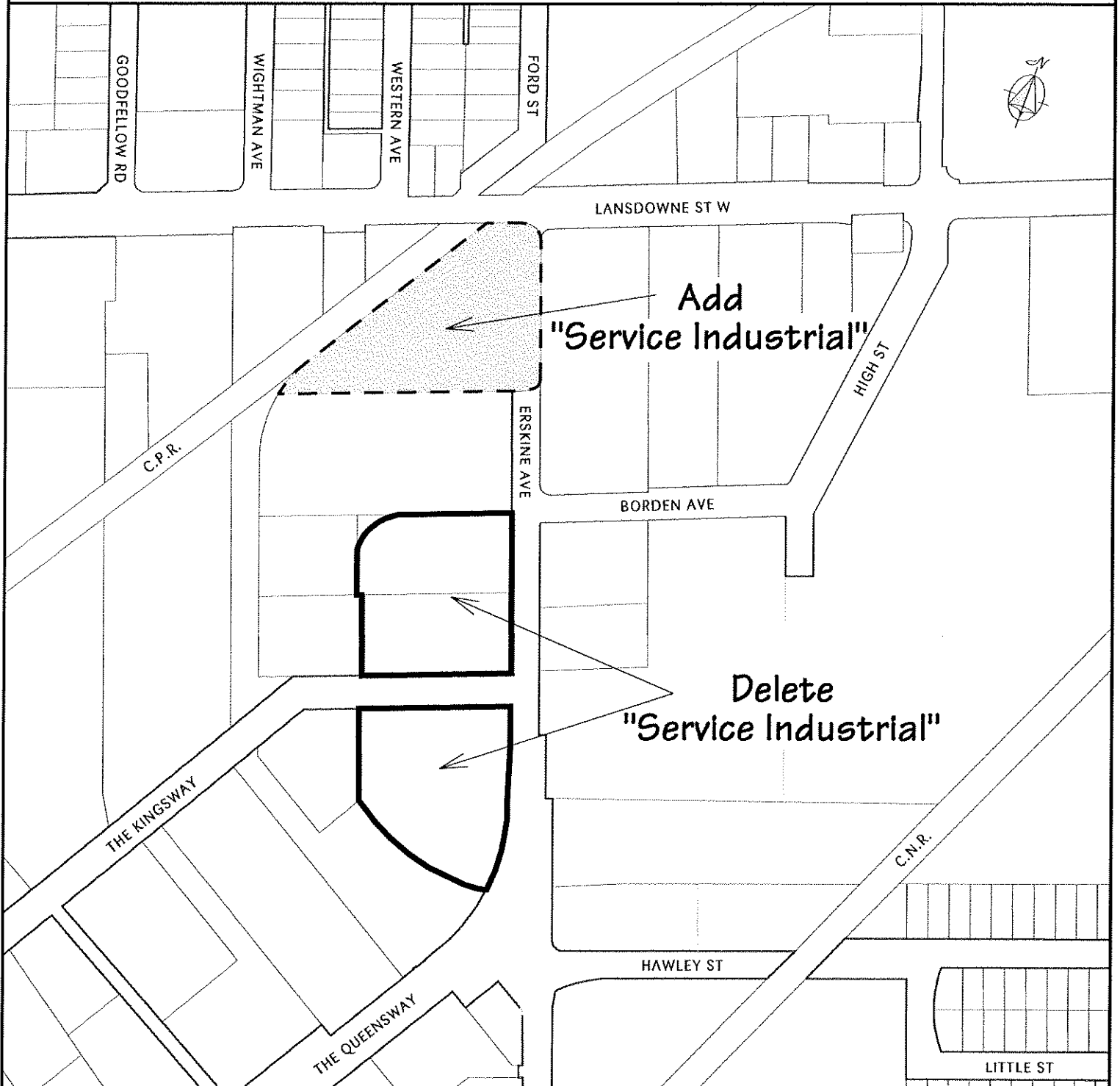
