BY-LAW NUMBER 03-230

BEING A BY-LAW TO AMEND CHAPTER 89 OF THE CITY OF PETERBOROUGH MUNICIPAL CODE WITH RESPECT TO BUILDING OFFICIALS - INSPECTORS

THE CORPORATION OF THE CITY OF PETERBOROUGH BY THE COUNCIL THEREOF HEREBY ENACTS AS FOLLOWS:

1. Chapter 89 of The Corporation of the City of Peterborough Municipal Code is hereby deleted in its entirety and the following substituted therefor:

**“Article 1
APPOINTMENTS**

89.1.1 Andrew Jeffrey Chalmers – Chief Building Official

Andrew Jeffrey Chalmers is hereby appointed Chief Building Official for The Corporation of the City of Peterborough for the purposes of the enforcement of the Ontario *Building Code Act* within the limits of the City of Peterborough.

89.1.2 Robert J. Waldron – First Acting Chief Building Official

Robert J. Waldron is hereby appointed Acting Chief Building Official for The Corporation of the City of Peterborough for the purpose of enforcement of the Ontario *Building Code Act* within the limits of the City of Peterborough in the absence of the Chief Building Official for The Corporation of the City of Peterborough.

89.1.3 Gregory P. Elcombe – Second Acting Chief Building Official

Gregory P. Elcombe is hereby appointed Acting Chief Official for The Corporation of the City of Peterborough for the purpose of enforcement of the Ontario *Building Code Act* within the limits of the City of Peterborough in the absence of the Chief Building Official and the First Acting Chief Building Official for The Corporation of the City of Peterborough

89.1.4 Inspectors

The following employees of The Corporation of the City of Peterborough are hereby appointed as Inspectors for the Corporation for the purposes of enforcement of the Ontario *Building Code Act*, within the limits of the City of Peterborough:
