BY-LAW NUMBER 05-050

**BEING A BY-LAW TO AMEND BY-LAW 93-100, BEING A BY-LAW
FOR THE REGULATION OF PARKING**

THE CORPORATION OF THE CITY OF PETERBOROUGH BY THE COUNCIL
THEREOF HEREBY ENACTS AS FOLLOWS:

By-law 93-100, is hereby amended as follows:

1. Section 9.2 is hereby deleted in its entirety and the following substituted therefor:

“9.2 No vehicle shall be parked upon those streets or parts of streets listed in Schedule 49 to this by-law between the hours of 9:00 a.m. and 6:00 p.m. from Monday to Friday unless sufficient fees, in accordance with Section 13 of this by-law have been deposited in the meter.”

2. Section 11 is hereby deleted in its entirety and the following substituted therefor:

“11. MAXIMUM DURATION OF PARKING

11.1 It shall be unlawful for any person to permit a vehicle to remain parked at a parking meter on a street or in the Library Lot for a consecutive period of more than two (2) hours, regardless of whether or not any time is shown on the meter.

11.2 It shall be unlawful for any person to permit a vehicle to remain parked in the Downie Street Lot, the Reid Street Lot or the Gas Works Lot for a consecutive period of more than five (5) hours, regardless of whether or not any time is shown on the meter.

11.3 It shall be unlawful for any person to permit a vehicle to remain parked in the Brock Street Lot, Del Crary Lot, King Street Parkade, Louis Street Lot, Simcoe Street Parking Garage or the Rehill Lot for a consecutive period of more than twenty-four (24) hours, unless the person holds a monthly parking permit.”

3. Section 13 is hereby deleted in its entirety and the following substituted therefor:

“13. PARKING RATES

13.1 The following rates shall apply to parking at a parking meter:

- (i) on a street – one (\$1.00) dollar per hour;
- (ii) in parking lot – one (\$1.00) dollar per hour.

13.2 The following parking rates shall apply in the Brock Street Parking Lot:

- (i) Hourly Parking – one (\$1.00) dollar per hour to a maximum amount of seven (\$7.00) dollars per day;
- (ii) Monthly Parking Permit – forty (\$40.00) dollars.

- 13.3 The following parking rates shall apply in the Louis Street Lot:
- (i) Hourly Parking – one (\$1.00) dollar per hour to a maximum amount of seven (\$7.00) dollars per day.
- 13.4 The following parking rates shall apply in the Simcoe Street Parking Garage:
- (i) Hourly Parking – first hour free, and subsequently one (\$1.00) dollar per hour to a maximum amount of seven (\$7.00) dollars per day,
 - (ii) Monthly Parking Permit – forty (\$40.00) dollars.
- 13.5 The following parking rates shall apply in the King Street Parkade:
- (i) Hourly Parking – first hour free, and subsequently one (\$1.00) dollar per hour to a maximum amount of seven (\$7.00) dollars per day,
 - (ii) Monthly Parking Permit – fifty (\$50.00) dollars.
- 13.6 The following parking rates shall apply in the Rehill Lot:
- (i) Monthly Parking Permit – thirty (\$30.00) dollars,
 - (ii) Three Month Parking Permit – seventy-five (\$75.00) dollars.
- 13.7 The following parking rates shall apply in the Del Cray Lot:
- (i) Hourly Parking –one (\$1.00) dollar per hour to a maximum of amount seven (\$7.00) dollars per day,
 - (ii) Monthly Parking Permit – thirty (\$30.00) dollars.
- 13.8 The following parking rates shall apply in the Chambers Street Parking Lot:
- (i) Hourly Parking –one (\$1.00) dollar per hour to a maximum amount of seven (\$7.00) dollars per day,”

4. Section 16 is hereby deleted in its entirety and the following substituted therefor:

“16. VOLUNTARY PAYMENT OF PENALTIES

- 16.1 Voluntary payment of the penalty shown on a parking infraction notice may be made within seven (7) days after the alleged violation has occurred by:
- (i) Making payment at City Hall, 500 George Street North, Peterborough K9H 3R9; or
 - (ii) Making payment at the Provincial Offences Office, 99 Simcoe Street, Peterborough, Ontario K9H 2H3; or
 - (iii) Depositing payment in any yellow courtesy box placed in the downtown area; or
 - (iv) Mailing payment to City Hall, 500 George Street North, Peterborough K9H 3R9.

16.2 The following voluntary payments shall be accepted in full satisfaction of the respective offences:

Park in a Crosswalk [s. 4.12(vi)]	\$10.00
Park within an Intersection [s. 4.12(iv)]	\$10.00
Park on Any street in such a manner as to interfere with the movement of traffic or the or the clearing of snow from the street [s. 4.12(ix)]	\$10.00
Park in such a position as will prevent the removal of any other vehicle previously parked or standing [s. 4.12(x)]	\$10.00
Park in a Fire Route[s. 6.30]	\$10.00
Park in Front of an Entrance to a Hotel [s. 6.17(ii)]	\$10.00
Park in Front of an Entrance to a Hospital [s. 6.17(iii)]	\$10.00
Park in front of main entrance to, or any emergency exit from, a theatre, auditorium, or public building, while assemblages are being held therein. [s. 6.17(i)]	\$10.00
Park longer Than 3 Hours [s.8.1]	\$10.00
Park Illegally at Meter [s.9.2]	\$10.00
Park Illegally in Lot [s. 10.1]	\$10.00
Park longer Than 2 Hours at Meter [s. 11.1]	\$10.00
Park Illegally in Downie Street, Reid Street or Gas Works Lot longer than 5 Hours [s. 11.2]	\$10.00
Park Illegally in Brock Street Lot, Del Cray Lot, Louis Street Lot, Rehill Lot, King Street Parkade, or Simcoe Street Parking Garage longer than 24 Hours [s. 11.3]	\$10.00"
