THE PARTY OF THE SECOND PART

WITNESSETH, that the party of the first part, for and in consideration of the payment or payments specified in the Quotation for this work, hereby agrees to furnish all necessary consulting engineering services, to the satisfaction of the Municipality, to do all the work as described hereafter and to complete such works in strict accordance with the Quotation Document and Terms of Reference, and all of which are to be read herewith and form part of this present Agreement as fully and completely to all intents and purposes as though all the stipulations hereof have been embodied herein.

DESCRIPTION OF THE WORK

The work under Quotation No. Q-06-06 is for provision of consulting engineering services for the detailed design and construction administration require to complete rehabilitation of the Lansdowne Street Bridge over the Otonabee River / Trent Canal, in the City of Peterborough, in 2006, as defined herein.

The Consultant further agrees that he will deliver the whole of the works completed in accordance with this Agreement within the time stipulated in Section 1.8 entitled PROGRESS OF THE WORK.

The Consultant agrees that any monies due to the Municipality as a result of non-completion of the works within the time stipulated may be deducted from any monies due to the Consultant on any account whatsoever.

IN CONSIDERATION WHEREOF, said party of the second part agrees to pay to the Consultant for all work done, the unit prices on the Quotation.

This agreement shall inure to the benefit of and be binding upon the heirs, executors, administrators and assigns of the parties hereto.

IN WITNESS THEREOF, the Consultant and the Municipality have hereunto signed their names and set their seals on the day first above written, or caused their corporate seals to be affixed, attested by the signature of their proper officers, as the case may be.
