WITNESSETH, that the party of the first part, for and in consideration of the payment or payments specified in the Tender for this work, hereby agrees to furnish all necessary machinery, tools, equipment, supplies, labour and other means of construction and, to the satisfaction of the Engineer, to do all the work as described hereafter, furnish all the materials except as herein otherwise specified, and to complete such works in strict accordance with the specifications and Tender therefore, which are identified and acknowledged in the Special Provisions, Specifications and Conditions attached to the Tender and all of which are to be read herewith and form part of this present Agreement as fully and completely to all intents and purposes at though all the stipulations hereof have been embodied herein.

**DESCRIPTION OF THE WORK**

A description of the work under Contract T-19-06 includes the cleaning and closed-circuit television inspection (CCTV) of various sanitary sewers within road allowances, easements, and public property in the City of Peterborough. This contract includes all associated restoration requirements.

AGREEMENT

This agreement shall inure to the benefit of and be binding upon the heirs, executors, administrators and assigns of the parties hereto.
