BEING A BY-LAW TO AMEND BY-LAW 04-177, A BYLAW TO AUTHORIZE THE EXECUTION OF AN AGREEMENT BETWEEN THE CORPORATION OF THE CITY OF PETERBOROUGH AND CLEAN HARBORS CANADA INC. FOR THE LOADING, TRANSPORTATION AND RECYCLING/DISPOSAL OF MISCELLANEOUS HOUSEHOLD HAZARDOUS WASTE (P-12-04)

Dear Mr. Zdelar:

I am pleased to advise that, at its meeting held on 4 September 2007, City Council adopted the recommendation to extend the current agreement between the Corporation of the City of Peterborough and Clean Harbors Canada, Inc. ("CHCI") for a period not exceeding twelve (12) months commencing on 1 November 2007. Council's decision reflects the possibility that the Province of Ontario may, within the next year, prescribe new regulations concerning the collection, transportation and disposal/recycling of Household Hazardous Wastes ("HHW"). It is the City's understand that such new regulations may prescribe new standards for the collection, transportation and disposal/recycling of HHW,

Accordingly, this letter confirms that the agreement, dated 27 August 2004, is hereby renewed, commencing 1 November 2007, for a period not exceeding twelve (12) months, and that the pricing for the extension period be adjusted to reflect a 3.6% increase in costs, as contained in the schedule attached to your letter of 12 September 2007.

In the event the Province of Ontario prescribes new regulations concerning the collection, transportation and disposal/recycling of HHW, the City will provide CHCI with ninety (90) calendar days notice of its intention to terminate the agreement. I can advise you that, during the ninety (90) day period, the City shall issue an RFP concerning the collection, transportation and disposal/recycling of HHW. In all other respects, the agreement continues in full

force and effect, according to the terms and conditions contained in RFP P-12-04.

Kindly execute the enclosed copy of this letter to acknowledge CHCI's receipt and concurrence with this renewal, and return it to the writer at your earliest convenience.
