**BEING A BY-LAW TO AMEND CHAPTER 106 OF THE CITY OF
PETERBOROUGH MUNICIPAL CODE**

THE CORPORATION OF THE CITY OF PETERBOROUGH, BY THE COUNCIL
THEREOF, ENACTS AS FOLLOWS:

1. Chapter 106 of the City of Peterborough Municipal Code is hereby repealed
and the following substituted therefor:

**“CHAPTER 106
ACTING FIRE CHIEF - APPOINTMENT**

**Article 1
Appointment**

106.1.1 Appointment – Acting Fire Chief

Trent Gervais is hereby appointed Acting Chief of the Fire Department of the City
of Peterborough and shall have the title of Acting Fire Chief, as per the authority
of the *Fire Protection and Prevention Act*, Section 6(1) Fire Chief, Municipalities.

**Article 2
Duties**

106.1.2 Imposed - by By-laws - Acts - Provincial- Federal

Trent Gervais shall perform the duties imposed on him by By-law 95-53, being a
by-law to establish and regulate the City of Peterborough Fire Department, and
other by-laws of the Corporation, the *Fire Protection and Prevention Act* and
such other Acts of the Legislature of Ontario or of the Parliament of Canada
relating to the prevention of fires and the protection of property against loss or
damage by fire.”

BEING A BY-LAW TO AMEND CHAPTER 106 OF THE CITY OF PETERBOROUGH MUNICIPAL CODE (FIRE CHIEF APPOINTMENT, TRENT D. GERVAIS)

THE CORPORATION OF THE CITY OF PETERBOROUGH BY THE COUNCIL THEREOF HEREBY ENACTS AS FOLLOWS:

1. Chapter 106 of the City of Peterborough Municipal Code is hereby repealed and the following substituted therefor:

**“CHAPTER 106
FIRE CHIEF APPOINTMENT**

**Article 1
Appointment**

106.1.1 Appointment – Trent D. Gervais

Trent D. Gervais is hereby appointed Chief of the Fire Department of the City of Peterborough and shall have the title of Fire Chief.

**Article 2
Duties**

106.1.2 Imposed - by By-laws - Acts - Provincial - Federal

Trent D. Gervais shall perform the duties imposed on him by By-law 95-53, being a by-law to establish and regulate the City of Peterborough Fire Department, and other by-laws of the Corporation, the *Fire Prevention and Protection Act, S.O. 1997, Chapter 4, Subsection 6 (1)*, and such other Acts of the Legislature of Ontario or of the Parliament of Canada relating to the prevention of fires and the protection of property against loss or damage by fire.”

2. Bylaws 04-022 and 08-180 are hereby repealed.
