NOTICE OF THE PASSING OF**

**DEVELOPMENT CHARGES BY-LAWS**

TAKE NOTICE that on December 6, 2004, the City of Peterborough passed the following Development Charges By-laws under Section 2 of the *Development Charges Act, 1997*, which impose both a City Wide Development Charge Rate and Specific Area Rates that apply in eight (8) different growth areas:

Development Charges are levied against new development and are a primary source of funding for growth related capital expenditures. The development charges imposed under the by-laws will apply to all new residential and non-residential development throughout the City, subject to certain terms, conditions and limited exemptions as identified in the by-law (s).

Schedule 1 below sets out the development charge rates that will apply under the various by-laws as of January 1, 2005 and as of January 1, 2006. Schedule 2 is a map of the City that shows the various growth areas.

The by-laws can also be examined at the City Clerk's Office between 8:30 a.m. to - 4:30 p.m. Monday through Friday, at the address shown below.

Any person or organization may appeal to the Ontario Municipal Board in respect to one or more of these by-laws by filing with the City Clerk of the Corporation of the City of Peterborough, on or before the **17th day of January, 2005**, a notice of appeal, under Section 14, setting out the objection to the by-law(s) and the reasons in support of the objection.
