The City of Peterborough is offering a \$50 rebate per toilet for the purchase of up to two low flow toilets that are replacing existing, less efficient toilets. The rebate program is available exclusively for residential units located within the City of Peterborough that are connected to both the municipal water and the municipal sanitary sewer system.

To be eligible for the rebate offer, the Applicant must:

- Purchase and install an eligible low flow toilet as approved by the City of Peterborough;
- Fill out and sign the application form and submit it with the original sales receipt.

NOTE: 1. The program does not apply to new construction, or new bathroom additions; it must be a replacement toilet.
2. The City reserves the right to an on-site inspection of the new toilet, if required.

In consideration of receiving the rebate under the City of Peterborough Low Flow Toilet Rebate Program, the undersigned acknowledges and agrees:

1. That the City of Peterborough may deny any application that does not meet Program requirements, which can be obtained by visiting www.peterborough.ca or by calling 705-742-7777 ext. 1441;
2. That the installation of the number of water efficient toilets indicated in this Application Form has been completed. The toilet(s) must be installed prior to submission of rebate request. The installation date must be included on the application;
3. That the Application form must be completed correctly and in full in order to permit the City to verify the information provided;
4. That the City of Peterborough or its agents may inspect all properties participating in this Program in order to confirm the information provided by the applicant;
5. That the City of Peterborough does not guarantee or warranty (i) the performance of any toilet; (ii) that its installation will be free of defects; (iii) the quality of workmanship;
6. To return the rebate to the City on request, if this Application contains any material misstatement or misrepresentation, or if the Applicant breaches any of term or condition contained herein;
7. The City of Peterborough reserves the right to alter or discontinue the program at any time. Submission of an application does not guarantee a rebate.
