How To Read Your Tax Bill

- A Property Identification: This section contains the identification information of your property.
B Tax Class: This section lists the classification(s) of your property.
C Value: This show the current value of your property as assessed by the Municipal Property Assessment Corporation (MPAC).

- D Municipal/Education Rates & Levies: This section provides a breakdown of your property taxes.
E Special Charges/Credits: This section will list any charges or credits that are specific to your property.
F Summary: This section summarizes your total taxes levied (both municipal and education), your total special charges and credits and any capping adjustments.

- G Payment Stubs: Payment stubs are to be submitted along with your payment.
H Schedule 2: This area is used for Residential, Farm, Managed Forest and Pipeline properties.
I Schedule 3: This area is used for the Commercial, Industrial and Multi-Residential property classes.
