

Peterborough Review Committee (PRC)

Hearing Form- Community Housing Tenant, Member or Applicant

The Peterborough Review Committee reviews decisions made by Housing Access Peterborough (HAP) or Community Housing Providers where the tenant, member or applicant doesn't agree with the decision. Please see attached brochure for more information.

Filling out this form and sending it in means that you are asking for a review of a decision. Before asking for a review you must first speak with the person who made the decision and they must decide that they will not change it.

A request for a review must be made within 20-days of the decision. If it has been longer than that, please include the reason for the extra time in your description below.

You will be invited to attend a hearing. You may bring someone with you to help you feel more comfortable. The Review Committee will be made up of two Housing Providers who were not involved in the original decision, as well as the Service Manager. Everyone, including the person who made the decision, will be in the room at the same time. Once everyone has given their information and the Committee has asked questions, you will be able to leave and the decision will be sent to you within 5 business days.

Please complete these forms, attach any relevant documentation, and submit to the contact below. An employee from Housing Services will contact you to confirm the date and time of the hearing. You will be asked to review the information in the hearing.
