

Ontario Regulation 20/17 under the *Green Energy Act*, 2009 requires owners of large properties with a gross floor area of 50,000 square feet and above to report their energy consumption and water use data to the Ministry of Energy on an annual basis. Visit <u>Guide to Energy and Water Reporting</u> for more information. The reporting requirement will be phased in as displayed in the following schedule:

By July 1, 2018 (information for 2017 calendar year)	250,000 square feet and larger	Not required to report in first year

By July 1, 2020 (information for 2019 calendar year)	50,000 square feet and larger	50,000 square feet and larger

For property owners requiring aggregated consumption for a suite-metered property, Peterborough Utilities Group will provide an account list including names and addresses for validation by the requestor.

Personal Information relating to identifiable individual customers will only be aggregated.

Please submit your data request as soon as possible. Requests received after June 1 may not be processed by the July 1 deadline.

STEP 1: Gather Necessary Information

Peterborough Utilities Group requires the following information before it can provide the energy consumption and water use data for your property:

- i. Account number for at least one of the accounts of the property you own or manage.
- ii. Ontario EWRB ID the unique number provided by the Ministry of Energy (MOE) for the property.
- iii. The property code for your property information which you can find on your property assessment and tax bill, or the Municipal Property Assessment Corporation (MPAC) website.
- iv. Gross Floor Area in square feet of the property for which you are requesting the energy consumption and water use data.

If you are a property manager, energy consultant or other third party requesting energy consumption and water use data on behalf of a property owner, the property owner must complete and sign the authorization section in PART (A) of this form to authorize Peterborough Utilities Group to release the data to you. Peterborough Utilities Group cannot process a request from a third party if this section is not completed and signed.
