11. Understand that I am giving up substantial legal rights by signing this Agreement. I have signed this Agreement freely without any inducement or assurance of any nature. I intend this Agreement to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this Agreement is held to be invalid, that the balance of this Agreement shall remain valid and binding.
10. Understand that in law, I am releasing the Indemnified Parties from any and all possible claims which I, or the Child, have or might have in the future arising out of the Child's participation in the Event and from all Risks and Dangers associated with or arising out of the Child's participation in the Event.
9. Was given a sufficient period of time to obtain independent legal advice and, I warrant that, either I did so or that I made an informed decision not to do so.
8. Have read this agreement carefully and I fully understand its terms.
7. Further agree that if, despite signing this Agreement, I, or anyone on my behalf or on the Child's behalf, makes a claim against on or more of the Indemnified Parties, that, without limiting the generality of the releases and discharges contained in this Agreement, that I will indemnify and hold harmless each of the said Indemnified Parties from any expenses, legal fees, losses, costs, damages or liability which any of the Indemnified Parties may incur as a result of such claim.
6. Hereby release, discharge and irrevocably covenant not to sue (1) the Corporation of the City of Peterborough, its employees, agents, or elected officials, and, if applicable, the City's insurer, or (2) the Peterborough Police Service, its employees, or officials (collectively, the "Indemnified Parties") and I release the Indemnified Parties from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the actions or inactions, whether negligent or not, of the Indemnified Parties, myself, the Child and of other persons.
5. Fully understand that the Risks and Dangers may be caused by (a) the Child's actions or inactions; (b) the actions or inactions of one or more other person(s); or (c) the non-negligent decisions or non-decisions of other persons. I also fully understand that the Child's participation in the Event may involve other risks such as economic loss or loss of opportunities, which may not be known or foreseeable at this time. I fully and freely accept and assume all such Risks and Dangers and the responsibility, both for myself and the Child, for all losses, costs, damages which I or the Child incur as a result of the Child's participation in the Event.
4. Fully understand, acknowledge and accept for myself and the Child that the Event involves risks and dangers, including: (a) serious bodily injury, including permanent disability, paralysis, and death, and (b) mental injury, upset or trauma ("Risks and Dangers").
3. Further agree and warrant that if, at any time, I think (a) conditions are unsafe, or (b) my Child's physical condition is not appropriate, that I will immediately discontinue the Child's further participation in the Event.
2. Irrevocably represent that the Child, is in good health and in proper physical condition to participate in the Event.
