## **Executive Summary**

• At the January 30, 2025, meeting, a request was made for a report on Van ridership.

## Background

Peterborough Transit began providing specialized service to passengers with physical and cognitive needs which prevented them from accessing regular transit buses. This service started in the 1980's with a passenger van, it was expanded to wheelchair accessible vehicles. Over the years, a variety of vehicles have been used, some with lifting devices others that could kneel and had a folding ramp.

Up until 2015, scheduling passenger service was manually entered into a ledger and was transferred each day into individual vehicle sheets which the drivers followed throughout the day.

In March of 2015, RouteMatch was purchased and implemented as the scheduling software employed for van services. This system was installed on a server and enabled on-the-fly updates to driver schedules, adding, removing and adjusting calls, relaying these changes to the tablet installed in the vehicle.

RouteMatch was replaced in April 2022 with a system called Via Mobility. This system is cloud based and offers a similar system to RouteMatch; however, it communicates with passengers via text messaging to notify them that the van will arrive in half an hour and then again at five minutes prior to the pick-up time. Via Mobility is the current program being used for scheduling the van service.

The Specialized Van Service consists of 11 vehicles, 7 of which are on the road during weekdays, 4 on Saturday and 4 on Sunday. The hours of operation are between 6:00 a.m. and 11:59 p.m. Monday to Friday, the service runs from 7:00 a.m. until 11:59 p.m. On Saturdays and Sundays, it runs from 8:00 a.m. until 8:00 p.m.

The 2024 statistics summary for Peterborough Transit Specialized Van Service shows that there are 428 active riders. There were 59,494 requested rides with 41,597 being completed. The completed rides rate is 69.9%.

The vans operated for 15,489.9 revenue hours and the productivity was 2.7 rides per hour. 2024 did show some improvement over 2023.

In 2023, the Via Mobility software was used for both an On-Demand service and the Specialized Van Service. Some of the On-Demand passengers were entered in the Specialized Transit ridership. To compare 2023 to 2024, there were 434 active riders, 57,738 rides requested with 39,108 completed rides. The completed ride rate was 67.7%.

In contrast to traditional transit, which achieves approximately 25 trips per hour in 2024, the vans are significantly less productive. Nevertheless, this service is an essential part of what transit offers.

The next full time driver position approved by council will be assigned to the Specialized Transit Van service.

## Conclusion

In summary, the van ridership consists of 428 active riders. In 2024, of the 59,494 requested rides there were 41,597 trips completed which is a 69.9% request to ride ratio. The trips per hour productivity of the van service is 2.7. Transit staff do strive to book every requested trip.
