Report: Bus Stop and Shelter Update, Report Number PTLC24-010

Subject

A Report to inform the Peterborough Transit Liaison Committee of the 2024 Bus stop and Shelter upgrades.

Recommendation

That the Peterborough Transit Liaison Committee approve the recommendation outlined in Report PTLC24-010, dated date of meeting October 24, 2024, of the Director, Transit Services as follows:

Executive Summary

- At the September 26th, 2024, PTLC meeting there was a request for an update on the progress of the Bus stops and Shelter upgrades.
- In 2019 Transit applied to the Invest in Canada Infrastructure Program (ICIP) for several capital projects. One of those was to upgrade bus stops and shelters.
- There are many bus stops in the city of Peterborough that don't have a suitable area for passengers to wait for or disembark a bus onto. Some are grass, some are a gravel shoulder, and others are very close to ditches.

- The current contract (ITT-06-24) involves earth excavation, grading, removal of
 existing asphalt roadway, concrete curb, concrete sidewalk, topsoil, sod, signs.
 Installation of new asphalt roadway, concrete curb, concrete sidewalk, topsoil and sod,
 and signs, and supply and installation of new transit shelters and concrete transit pads.
- The current project lists 49 locations to be serviced by 2025. The locations are comprised by transit staff, including feedback from the PTLC. General population and consumer group requests are included in the process. The City's Engineering Services Department oversees awarding the contract, construction of the infrastructure and ensures that all standards are adhered to.
- The contractor mobilized to site on July 31, 2024, and will continue to mobilize to various locations across the city. To view all locations, please refer to the City's current construction project map. It can be found by visiting peterborough.ca/ConstructionMap
- As of October 18^{th,} 2024, the project was 20% complete.

Background

The City of Peterborough has an estimated 700 bus stops within the city. There are 92 shelters, 10 are owned by Pattison, 2 are owned by Fleming College, one by Walmart and one by Trent University.

In 2018 there were 68 total shelters. Transit continues to apply for funding and upgrade stops and install shelters for passenger safety and comfort.

Report: Transit Onboard Camera System, Report Number PTLC24-011

Subject

A Report to inform the Peterborough Transit Liaison Committee of the status of the Transit Onboard Camera System.

Recommendation

Executive Summary

- On September 26th, 2024, PTLC meeting there was a request for an update on transit on-board camera system.
- The Intelligent Transit system was purchased by the City of Peterborough in 2019.
 This consisted of several components such as Vehicle Diagnostics, Destination
 Sign, Stop and Preboard Announcements, Computer Aided Dispatch, Automated
 Vehicle Location System, Automated Passenger counting a Driver Console,
 Onboard Cameras etc.
- The onboard camera system is a hard drive recording system. Some municipalities
 use a cloud-based system which allows remote access. With a hard drive system,

any access to information requires the removal of the hard drive and installation of it on a docking station. Drivers have a button they can push which identifies a time on the recordings for easy identification. There are 7 cameras installed on each bus. Four have been mounted on the outside of the vehicle and three on the inside.

- As part of the City's policy and Freedom of Information Act, anytime a camera's information is viewed, the reason, date of access, person's name and signature must be entered into a logbook. These logbooks are audited annually.
- The benefits of these cameras are to provide accurate information on incidents, passenger concerns and collisions. Cameras have been installed on all transit buses; however, they have not been activated. A corporate policy and stickers (installed on each vehicle) notifying the public that the vehicle is equipped with onboard cameras is required to activate the cameras. The stickers have been acquired and the policy is near completion.

Background

Transit systems across the country have been installing on-board camera systems on their vehicles for over a decade. They are beneficial with investigations regarding collisions, customer concerns, passenger injuries and other issues where video helps remove any confusion.

Peterborough Transit applied for ICIP funding in 2019 for a package of technological tools; an onboard camera system was included in the package. The cameras have been installed and a docking station for viewing images has been set up, including a safe for securing saved information per the chain of custody requirements. Once the corporate policy is completed, the cameras will be activated.

Conclusion

Peterborough Transit has installed cameras on all the buses in the fleet. The benefits of these cameras are to provide accurate information in incidents, passenger concerns and collisions. A policy is required before the cameras can be made operational; this policy is near completion. Once complete, stickers advising that the bus is equipped with onboard cameras, will be placed on all vehicles, and the cameras will be made active.

Executive Summary

 At the September 26, 2024, PTLC meeting, a request was made for the status of the Ridership Etiquette Video Project with Trent University and Fleming College.

Background

Over the past year, there has been a noticeable decline in the passenger etiquette on Peterborough Transit buses. This seems to mirror the growing disrespect that transit staff are experiencing from riders (please see Report number PTLC24-007 "Deescalation Training).

Early in 2024, there was a recommendation to have transit staff team up with Trent University and Fleming College to create a video on how to behave while riding Peterborough Transit buses.

This video project is still in the concept phase and is not yet finished. However, transit staff have been working with the Fleming and Trent Security teams to assist passengers at the bus stops on both campuses, providing guidance on how to board and use the buses. Additionally, there has been ongoing communication with Fleming's International Student Affairs to address cultural differences related to using transit services. Transit staff will continue collaborating with Trent and Fleming to complete the project.
