



# **Community Housing Application**

## Who is Housing Access Peterborough (HAP)?

Housing Access Peterborough manages the centralized wait list for Rent-Geared to Income (RGI) as well as Peterborough Housing Corporation's (PHC) Affordable Housing wait list in the City and County of Peterborough. The HAP office is located at the Peterborough Social Services office 178 Charlotte St, Peterborough, ON in the Charlotte Mews.

## What is this application for?

This application is for those interested in joining the Centralized Wait list for Rent-Geared-to-Income (RGI) Housing and/or for PHC's Affordable Housing.

**Rent-Geared-to-Income (RGI)** housing is available through the Centralized Wait List. The Centralized Wait list is what Peterborough Housing Corporation (PHC), some private non-profit housing providers and one co-operative housing provider must use to find tenants for their buildings. Rent-Geared-to-Income means that rent is set to be no more than 30% of your income. Some RGI units are in private landlord buildings. These units are referred to as "rent supplement units".

**PHC Affordable Housing** is affordable units set at or below Average Market Rent (AMR) and is not geared to the tenant's income. Rents for Affordable Housing units are generally set between 80% to 100% of the average market rent set by the Province. Rental rates for these units typically increase each year, as per provincial rent control guidelines.

### How long before you are housed?

Your wait time depends on many factors, including how many places you apply to and where you qualify based on vacancy and turnover in selected buildings.

### Can I be placed on a priority list?

**Special Priority Policy (SPP)** is available to individuals applying for priority access for RGI housing in the City and County of Peterborough. Only people fleeing family/domestic abuse and human trafficking will be offered priority placement on the waitlist.

There is no priority placement for the Affordable Housing waitlist.

# Confirm if you are Eligible

Before you apply, confirm you are eligible. Please only apply for RGI and Affordable Housing if you meet the following criteria:

- 1. You can live independently without support services or can arrange your own supports.
- 2. You are, or someone else on your application is, over 16 years old.
- **3.** You are a Canadian Citizen, a permanent resident of Canada or a refugee claimant, or you are applying to become a permanent resident. You are not under a removal order to leave Canada.
- **4.** You do not owe money to any social housing provider in Ontario.

(Note: You can apply if you have a payment arrangement in place).

- **5.** You, or any person on your application has not been found guilty in the last 2 years of an offense related to RGI assistance.
- 6. Your household income is within the allowable limits.
  - Refer to the "Allowable Income Limits for Rent-Geared-to-Income" table below.
  - Refer to the "Affordable building Selection" Table for PHC Affordable Housing on pages 17 & 18).
- 7. Proof of Custody for every child on your application that does not live in the household full time.
- 8. Your total household assets fall under the asset limit set by the City of Peterborough. As of July 1, 2023, all clients who are either on the waitlist or applying to be on the waitlist will need to declare that their total household assets are lower than \$75,000.00.

## Allowable Income Limits for Rent-Geared-to-Income

These limits reflect the maximum income you have to apply for RGI housing. For example, if you are seeking a 1-bedroom unit in the City of Peterborough, you cannot have a yearly income over \$46,000.

## Good to Know / Important Reminders

- If you own a residential property that is suitable for year-round occupancy, you must agree to sell within 6 months of being housed.
- You can be declined housing if you have been evicted from another social housing site in Ontario within the last 5 years because of certain types of illegal activity and if you are a safety risk to others.
- Each person on the application form must pursue and supply all sources of eligible income.
- You can send your supporting documents electronically. Contact HAP for more information.
- Tell us right away if:
  - o you move
  - o your telephone number changes
  - o your email address changes
- You will be removed from the wait list if we are not able to contact you to offer housing.
- We will contact you every year to update your information.

#### Part G: Housing Preferences and Needs

#### G.1 Instructions




